## SECTION I. PROCUREMENT OBJECTIVE

### 1.1 Introduction and Background Info

The Maryland Clean Energy Center (MCEC) is a green bank and corporate instrumentality of the state of Maryland which advances the adoption of clean energy generation and storage, as well as energy efficiency projects, products, services and technologies. MCEC leverages private capital to help homeowners, businesses, and government entities reduce energy costs. MCEC and the Clients we support have established policy mandates and developed goals to significantly reduce greenhouse gas emissions in the near term, and transition rapidly to clean energy supply for both transportation and the built environment.

MCEC is excited to be working with Baltimore County to facilitate an Electric Vehicle Infrastructure Assessment which will provide the County with an understanding of the following:

- Electric vehicle supply equipment (EVSE);
- Site evaluation and station locating;
- Vehicle replacement scheduling, and;
- Other parameters as specified in the Scope of Services, Section III of this RFP.

#### About Baltimore County

With nationally recognized public schools, 20 colleges in the region to provide a skilled workforce, abundant recreational opportunities and tight-knit communities, Baltimore County has something for everyone. Located in the geographic center of Maryland, Baltimore County almost entirely surrounds the city of Baltimore, which was split off as an independent city in 1851. The County is the largest jurisdiction in the metropolitan area, with a population of more than 800,000. Baltimore County and its County Seat – Towson – form a diverse business community located centrally along I-95, directly accessing the East Coast market. With 612 square miles of land and a deep-water port, Baltimore County has the third largest land area, the third largest population and the second highest number of jobs in Maryland. The County consistently receives AAA bond ratings from Moody's Fitch Ratings and Standard & Poor's.

The County Executive has set a goal of transitioning the County government's vehicle fleet toward electric and hybrid vehicles to reduce greenhouse gas emissions and fossil fuel energy consumption, demonstrate regional leadership in addressing climate change, and save long-term operational costs associated with fuel and maintenance. Baltimore County Executive Order 2021-024 calls for the electrification of 10% of the County's passenger vehicles and light-duty trucks, as well as the installation of the necessary charging infrastructure to support these vehicles, by 2030.

The current State of Maryland greenhouse gas (GHG) emissions reductions goals formalized via the Climate Solutions Now Act (CSNA) require a 60% GHG reduction by 2031, and net-zero emissions by 2045. Vehicle electrification is a primary strategy for reducing carbon emissions. Maryland continues to experience significant growth in EV ownership. This growth is supported by lower vehicle costs, state and federal incentives, the rise in the availability of makes and models, as well as the increasing availability of charging infrastructure across the State.



Regarding Baltimore County government: The Vehicle Operations and Maintenance (VOM) division, within the Office of Budget and Finance (OBF), is responsible for the acquisition and maintenance of approximately 1,486 automobiles and light duty trucks under 14,000 pounds of gross vehicle weight per unit. Of this number, roughly 1,062 vehicles are considered passenger vehicles. VOM serves most County agencies with fleet vehicles, as well as Public Safety, Police, Fire, Sheriff, and the Department of Corrections.

The Equipment Maintenance (EM) division, within the Bureau of Highways and Equipment Maintenance in the Department of Public Works and Transportation (DPWT), provides comprehensive preventive maintenance and repair services for the County’s fleet. EM purchases and maintains the County’s fire and emergency medical services apparatus (engines, ambulances, tractor-drawn aerial ladders and specialty units), 381 service and work trucks, 234 pieces of heavy equipment (front end loaders, backhoes, tractors, and mowers), and nearly 2,600 pieces of small-engine equipment (push mowers, string trimmers, chain saws, and blowers).

#### **1.5 Questions and Inquiries**

All questions and inquiries should be directed to the Procurement Officer identified in Section 1.2 above. Questions must be submitted in writing by mail or email and received by the Procurement Officer before 5:00 PM EST Friday, October 6, 2023. Oral questions will not be accepted. If a question or inquiry pertains to a specific section of the RFP, the page and section number(s) must be referenced.

#### **1.6 Submission Deadline**

In order to be eligible for consideration, responses must be received by no later than 5:00 PM EST Friday, October 20, 2023. Vendors must email responses and confirm receipt. Any response received after the submission deadline, no matter what the reason, will be deemed unacceptable. Proposals or unsolicited amendments to proposals arriving after the closing date and time will not be considered.

#### **1.7 Duration of Offer**

Proposals submitted in response to this solicitation are irrevocable for 120 days following the closing date. This period may be extended at the Procurement Officer's request only by an Offeror's written agreement.

### **SECTION II. GENERAL INFORMATION**

#### **2.1 Purpose**

The overall purpose of this RFP is to provide information to Offerors interested in preparing and submitting proposals to meet the specified requirements for this Electric Vehicle Infrastructure Assessment.



## **2.2 Revisions to the RFP**

MCEC reserves the right to amend this RFP at any time prior to the proposal due date and time. If it becomes necessary to revise this RFP, amendments will be provided to all prospective Offerors that were sent this RFP or are otherwise known by the Procurement Officer to have obtained this RFP.

## **2.3 Cancellation of the RFP; Rejection of All Proposals**

MCEC may cancel this RFP, in whole or in part, or may reject all proposals submitted in response, whenever this action is determined to be fiscally advantageous to MCEC or otherwise in the State's best interests.

## **2.4 Proposal Acceptance; Discussions**

MCEC reserves the right to accept or reject any proposals, in whole or in part, received in response to this RFP, to waive or permit cure of minor irregularities, and to conduct discussions with all qualified Offerors in any manner necessary to serve the best interests of MCEC. MCEC also reserves the right, in its sole discretion, to award a Contract based upon the written proposals received without prior discussions or negotiations.

## **2.5 Interviews/Oral Presentation**

MCEC may conduct interviews with qualifying Offerors. In addition, in support of their proposals, Offerors may be required to make an oral presentation. Interviews and oral presentations must be conducted within two calendar weeks after MCEC has requested an Offeror to do so. Failure to meet with MCEC for an interview or to make an oral presentation within this time period may prevent the Offeror's proposal from receiving further consideration. The main point of contact proposed in the Offeror's proposal must be present during these interviews.

## **2.6 Incurred Expenses**

MCEC will not be responsible for any costs incurred by an Offeror in preparing and submitting a proposal in response to this RFP.

## **2.7 Proposal Form**

Proposals should be prepared simply and economically, providing a straightforward, concise description of the Offeror's proposal for meeting the requirements of this procurement. Only electronically transmitted proposals will be accepted and shall be submitted to the Procurement Officer by 5:00 PM EST Friday, October 20, 2023 via email to the following address: [brupert@mdcleanenergy.com](mailto:brupert@mdcleanenergy.com).

## **2.8 Multiple Proposals**

Multiple and Alternate proposals will not be acceptable.



## **2.9 Access to Public Records Act Notice**

An Offeror should give specific attention to the identification of those portions of its proposal that it considers confidential, including but not limited to, proprietary commercial information or trade secrets, and provide justification why such materials, upon request, should not be disclosed by MCEC under the Public Information Act, General Provisions Article, Title 4, Annotated Code of Maryland. Careful consideration should be given before confidential information is submitted to MCEC as part of your proposal. Review should include whether it is critical for evaluating a proposal, and whether general, non-confidential information, may be adequate for review purposes.

## **2.10 Proposal Opening**

Proposals will not be opened publicly. If a contract is awarded, those portions of the proposal available under Maryland laws regarding access to public information will be made available upon written request to the Procurement Officer.

## **2.11 Compliance with Law**

By submitting an offer in response to this RFP, the Offeror, if selected for award, agrees that it will comply with all federal, State of Maryland, and local laws, regulations, and rules applicable to its activities and obligations under the Contract.

## **2.12 Arrearages**

By submitting an offer in response to this RFP, the Offeror shall be deemed to represent that it is not in arrears in the payment of any obligation due and owing the State of Maryland or any department or unit thereof, including the payment of taxes and employee benefits, and if selected for award, that it shall not become in arrears during the term of the Contract.

## **2.13 Acceptance of Terms and Conditions**

By submitting an offer in response to this RFP, an Offeror shall be deemed to have accepted all the terms, conditions, and requirements set forth in this RFP unless otherwise clearly noted and explained in its proposal.

## **2.14 Bid/Proposal Affidavit**

A completed Bid/Proposal Affidavit must accompany all proposals submitted by an Offeror. A copy of this affidavit is included as Appendix 1 attached to this RFP.

## **2.15 Contract Affidavit**

All Offerors are advised that if a contract is awarded as a result of this solicitation, the successful Offeror will be required to complete a Contract Affidavit. A copy of this affidavit is included for informational purposes as Appendix 2 attached to this RFP. This affidavit need not be submitted with an Offeror's proposal.



### **2.16 Order of Precedence**

The contract between the parties will be embodied in the contract documents which will consist of the following, listed in their order of precedence:

1. The contract and contract modifications executed by both parties;
2. This RFP; and
3. Vendor's proposal.

Modifications of the order of precedence provision of this solicitation will not be accepted. If any terms and conditions inconsistent with requirements of the solicitation are proposed, those terms and conditions must be stated in the proposal.

### **2.17 Contract Award**

MCEC anticipates making one award under this solicitation, but is not precluded from selecting a second firm if it is in the best interest of MCEC to do so. It may award a contract based on initial applications without discussion, or following limited discussion, negotiations, or interviews. Each offer should be submitted using the most favorable cost and technical terms. MCEC may request additional data or material to support applications. MCEC expects to notify proposers in approximately thirty (30) days from the proposal due date whether your proposal has been selected to receive an award.

### **2.18 RFP Modifications**

MCEC also reserves the right to correct any arithmetic errors, to change the final due date and time for the proposals, to accept or reject any of the firm's employees assigned to provide services on this project, and to require their replacement at any time, and to reject any proposal containing false or misleading statements or that provides references that do not support an attribute or a condition claimed by the proposer.

### **2.19 Limitation**

This solicitation does not commit MCEC to award a contract, pay any costs incurred in preparing a proposal, or to procure or contract for services or supplies. MCEC reserves the right to accept or reject any or all proposals received, to negotiate with all qualified sources, or to cancel in part or in its entirety the solicitation when it is in MCEC's best interest.

### **2.20 Performance of Services**

The Vendor shall perform the services within the limits prescribed by MCEC in a manner consistent with that level of care and skill ordinarily exercised by other independent public advisors under similar circumstances at the time the services are performed.



## **2.21 Term**

A contract to be awarded pursuant to the RFP shall begin on the date that the contract is signed by both parties and continue until all deliverables are complete, as mutually agreed in writing by the Parties, and in any case for a period not to exceed two years from the date of contract award.

## **SECTION III. SCOPE OF SERVICES AND REQUIREMENTS**

### **3.1 Background**

MCEC is a State-public corporation and an instrumentality of the State of Maryland that has been authorized to: 1) Promote economic development and jobs in the clean energy industry sector in the State; 2) Promote the deployment of clean energy technology in the State; 3) Serve as an incubator for the development of clean energy industry in the State; 4) Collect, analyze, and disseminate industry data; and, 5) Provide outreach and technical support to further the clean energy industry in the State. MCEC's program priorities range from providing clean energy initiative funding, technology commercialization and business incubation, and workforce development and training.

MCEC is governed by a Board of Directors that consists of 9 individuals that bring a wide range of perspectives and experience to MCEC's operations. MCEC employs a small staff and the Attorney General's Office provides legal services to the organization.

The purpose of this RFP is to enable MCEC to procure the services of qualified professional service provider(s), hereinafter referred to as ("Consultant") with expertise and understanding of electric vehicle supply equipment (EVSE) site evaluation and station locating, and vehicle replacement scheduling.

Specifically, ~~by December 31, 2023~~ **by or before May 31, 2024**, the Consultant shall complete an EV infrastructure plan and adopt recommendations and a timeline for integration of EVSE in Baltimore County facility locations. The infrastructure plan shall include annual conversion goals for FY2024, FY2025, FY2026 and FY2030. The Consultant will be required to isolate and recommend rebate and grant opportunities for EVSE and EV replacements to meet targeting and recommended goals, as well as alternative financing options.

A major element of the assessment will be for the Consultant to assist individual department managers in understanding and determining the varied elements of EVSE and vehicle replacement budgeting and scheduling, as well as set realistic targeted goals to meet identified charging station targets for FY2024, FY2025, FY2026, and FY2030.

### **3.2 Required Services**

The following shall be required of the Consultant:

- Furnish all necessary labor, materials, and standard business equipment needed to complete the work. All work will require review and acceptance by the County Project Manager and the project team.



- Participate in a weekly teams call with the Project Manager to assist with requests for information from other County departments, monitor Consultant performance, and to assist in keeping the project on schedule.
- Participate in a bi-weekly Teams call to keep the project Team updated of progress and to request any data necessary to complete the project in time.
- Provide all raw data and reports in a standard electronic, editable format while adhering to the project schedule.
- The Consultant shall provide graphical and written information relating to cost of ownership, return on investments, air quality and environmental benefits, life cycle, and maintenance compared to internal combustion vehicles, and their process for data gathering necessary to complete the assessment, determine vehicle replacement scheduling and share this information with the Project Manager for use in the County’s project outreach planning.
- Consultant shall perform EVSE Site Assessments of up to 15 locations based on the needs of individual County departments:
  - Electric load studies and duty cycles will need to be completed. Electric utility account numbers, addresses and utility contacts will be provided to Consultant. All utility account and meter information must be requested by the service provider. Where available Baltimore County will provide this data upfront.
  - Upon execution of the contract, the Consultant shall provide a list of utility account and facility specific infrastructure related information needed to begin work. County will acknowledge the list and within 10 working days provide details of available data and information that the Consultant will need to provide or extract.
  - Complete a detailed assessment, scope of work and pricing for all infrastructure construction including paneling, wiring, trenching, curbing, and all necessary costs to have a fully functional charging station
  - Distribution Grid Upgrades- New charging loads may require upgraded or new utility feeders, substation modernization, and even new substations.
  - Data shall be used to develop a vehicle replacement and infrastructure construction schedule for each department/location/facility that addresses the needs of charging station targets for FY2024, FY2025, FY2026, and FY2030 at a minimum and shall include specific cost estimates for each charging location.
  - The vehicle replacement schedule shall include cost savings by year for gasoline fuel and maintenance as well as total cost of ownership based on vehicles recommended.
  - Data shall also be used to calculate and detail emission reduction estimates in the final report.
  - Data collected from these meetings shall be used to identify EVSE needs and station locations, including current available electrical capacity based on the most appropriate electrical panel(s) to support charging stations and the number and type of charging ports at each location and shall clearly isolate station construction scheduling, specific to FY2024, FY2025, FY2026, and FY2030.
  - Specific budget estimates for each site and recommended alternatives should be included. Alternatives may include solar and battery storage as appropriate.



- Evaluate each charging location for potential future use as a publicly accessible charging location.
- The Plan shall include identifying infrastructure and construction related requirements including parking codes, building codes, zoning issues, permitting and inspections.
- Specific options available for networked EVSE equipment with detailed options, costs, and recommendations
- The plan shall include identifying all fleet vehicle opportunities for rebates, local, State or Federal subsidies or funding, trade in options and incentives, and procurement recommendations. The plan shall include a best-practice guide for implementation as to an EV charging and parking etiquette/County Policy.
- The planning process incorporates calculated savings based on future charging or production loads. To futureproof design, consider growth over five to ten years (and longer) to anticipate power capacity for a facility.
- Recommend overall approaches for:
  - ZEV infrastructure at leased facilities (ex: green lease agreements, portable chargers, etc.).
  - Charging strategies and best practices for load management, rotating vehicle charging schedules, energy efficiency, cost savings, and vehicle battery maintenance.
  - Policies and/or best practices to support implementation.
- Consultant shall Provide a draft EV Infrastructure Plan at the following stages and include:
  - 30% Review. Shall include a draft brief Introduction, draft Table of Contents, and draft Appendix. It should include a brief outline and formatting of the final document. Due approximately nine weeks after contract award with a two-week review period (~2/9/2024).
  - 60% Review. Shall include a more complete Table of Contents, draft content of each EVSE site location identified including available power and number of charging ports recommended, a draft EVSE cost estimate specific to each location, site location construction scheduling and phasing, and a draft number of vehicles that can be replaced during the next 3-5 years with estimated costs identified by each participating department or other classification/category as provided by the County. The Appendix should also include a workable County-wide solution for capturing emissions reductions that can be reported easily. Due four weeks after 30% review comments are received (~3/8/2024).
  - 90% Review. This shall read as a finished document. It should include all final data, recommendations, and costs. It shall be submitted for a two-week review period for any final comments. Due four weeks after 60% review comments are received (~4/5/2024).
  - Final plan submittal is due three weeks after 90% review comments are received (~4/26/2024).
- Consultant shall research existing Emission Reductions Calculators and recommend a standardized solution for Countywide use:
  - Evaluate current emissions reduction calculator tools to recommend a simplified solution.



- The emissions reductions calculator tool should be an existing tool that is evaluated by the Consultant and proposed to the County as a workable solution to use as a Countywide standard.
- Consultant shall research and isolate both EVSE and EV rebates and grant opportunities specific to County fleets.
  - The plan shall include identifying all fleet vehicle opportunities for rebates, local, State or Federal subsidies or funding, trade in options and incentives, and procurement recommendations.
  - Recommend specific funding opportunities per the Consultant's recommended EVSE implementation schedule.
  - Recommend specific funding opportunities per the Consultant's recommended vehicle replacement schedule.
- Optimize On-Site Energy - Evaluate options for on-site renewable energy and storage to minimize peak demand charges, balance loads, and lower the cost of clean energy.
- Conduct Utility Coordination- Start local and regional utility engagement early to develop a power delivery roadmap that leverages utility programs and charging rates.
- Timeline for the Project
  - Consultant shall provide a final EV Infrastructure Plan and functioning GIS Emissions Calculator no later than January 10, 2023.
- Qualifications for Consultant
  - 5 years' expert-level knowledge and experience gathering fleet data for the purpose of developing an EV replacement program.
  - 5 years' expert-level knowledge and experience in conducting EVSE site visits and identify EVSE needs and associated installation costs.
  - 5 years' expert-level knowledge and experience in coordinating with local utility companies specific to EVSE installation.
  - 5 years' expert-level knowledge and experience in coordinating with local municipalities specific to EVSE installation.
  - 5 years' expert-level knowledge and experience in coordinating with local permitting agencies specific to EVSE installation.
  - 5 years' expert-level knowledge and experience in performing emissions reductions calculations utilizing an emissions reduction calculator.
  - 5 years' expert-level knowledge and experience in developing GIS mapping and public interface solutions.

#### **SECTION IV. PROPOSAL REQUIREMENTS**

Each bidder shall carefully examine the RFP and all amendments, exhibits, revisions, and other data and materials provided with respect to this RFP process. Bidders should familiarize themselves with all proposal requirements prior to submitting their proposal.



A proposal should not be excessively long or submitted in an elaborate format. Unnecessary attachments beyond those sufficient to present a complete, comprehensive, and effective response will not influence the evaluation of the proposal. Each page of the proposal should state the name of the Offeror and the page number.

#### **4.1 Management and Qualifications**

4.1.1. Describe your organizational structure.

4.1.2. Briefly discuss your firm's overall experience, including experience with public and private financial markets. In particular, describe any services you have performed of similar nature.

4.1.3. Describe any technical knowledge or related expertise which may be of benefit to delivery of the Scope of Services specified in Section III of this RFP. Provide a project organization and management description that describes the unique capabilities of your firm and the individuals assigned as Consultants related to the proposed Scope of Work.

4.1.4. Provide the names of personnel in the firm who will be assigned to and their experience in performing services similar to those requested in this RFP. Include resumes for all employees proposed to be assigned to this project. Include a description of each employee's function in the company, title, office address, and number of years of service with the firm and other relevant past experience. Describe the availability of the lead person(s) for consultation with Program Administrators, including his or her ability to meet with Program Administrators. (Resumes may be included as an appendix.)

4.1.5. Describe your firm's experience and expertise working with public entities and local municipalities, particularly agencies, authorities, and instrumentalities of the State of Maryland.

4.1.6. Briefly describe the services you expect to provide to MCEC and the County. Indicate whether your firm is prepared to render the services enumerated in this RFP using its own resources. Discuss the approach your firm would take to meet the requirements of this RFP, including: a specific time line of milestones for measurable outcomes; expectations for MCEC and County staff, stakeholder engagement, and plans for graphic presentation in delivery of reports.

4.1.7. Discuss fully any conflicts of interest, actual or perceived, which might arise in connection with your firm's involvement with this RFP. If conflicts do or might exist, describe how your firm would resolve them.

4.1.8. In addition, the proposal should contain:

- (a) Name of firm.
- (b) Mailing address of the office from which the proposal is being submitted.
- (c) Name of individual who will represent firm as primary contact person on matters relating to the proposal
- (d) Telephone number, fax number, and E-mail address, if applicable.
- (e) Hourly rates for no more than four classes of personnel: principal, professional, para-professional, and staff. The rates will include all expenses.



## **SECTION VI. PROPOSAL EVALUATION**

Proposals meeting the RFP requirements will be evaluated as follows:

A selection committee consisting of representatives from MCEC and Baltimore County will review the Technical Proposals to determine if they each meet the requirements of this RFP. Following this initial review, the selection committee will review all Price Proposals. Following this review, MCEC may develop a short list of Offerors who will be eligible for further consideration and will be asked to interview with and/or make oral presentations to the selection committee as set forth in Section 2.5 above.

Following any presentations or, if the selection committee believes that it has sufficient information based upon its review of the Proposals without presentations, the selection committee will recommend an Offeror to the MCEC Board of Directors for approval. The selection committee's recommendation, and any final Board approval, will be based upon the determination of the selection committee and the Board, in their sole judgment, as to which Proposal would provide MCEC with the most advantageous and comprehensive combination of technical expertise, reputation, and price, while also assessing the minority business enterprise goals of MCEC.

## **SECTION VII. COOPERATIVE RIDER CLAUSE**

MCEC, as an agent to Memorandum of Understanding (MOU) or Memorandum of Agreement (MOA) Clients, extends the right to utilize all of the terms, conditions, specifications, and unit or other prices of any contract resulting from this RFP to other public and not-for-profit entities participating in current MOU and/or MOA with MCEC. This is conditioned upon mutual agreement based on the Rider Clause Approval Form provided as Appendix 4.

If awarded, Contractor(s) agrees to notify MCEC of an MOU or MOA Client's desire to use any Contract resulting from this RFP within 30 days of receiving said requests and to complete the form provided as Appendix 4.

MCEC assumes no authority, liability, or obligation on behalf of any MOU or MOA Client using a contract resulting from this RFP, or any Contractor, or any other entity with respect to this procurement or any contract resulting from it. In addition, MCEC MOU and/or MOA Clients may have other or additional terms and conditions that must be met by the Contractor.

1. Services to be Provided.

Pending resolution of a claim, Contractor must proceed diligently with the performance of the Agreement in accordance with the Contract Officer's decision. Unless a lesser period is provided by law, Contractor must file a written notice of claim with the Contract Officer within thirty days after the basis for the claim is known or should have been known, whichever is earlier. Contemporaneously with or within thirty days of the filing of a notice of claim, but no later than the date of final payment under the Agreement, Contractor must submit to the Contract Officer its written claim containing the information specified in COMAR 21.10.04.02.

7. Termination for Convenience. MCEC may terminate the performance of work under this Agreement in whole, or, from time to time, in part, whenever MCEC determines that such termination is in the best interest of MCEC. MCEC shall pay all reasonable costs associated with this Agreement that Contractor has incurred up to the date of termination and all reasonable costs associated with termination of the Agreement. MCEC may not reimburse Contractor for any anticipatory profits that have not been earned up to the date of termination.

8. Termination for Default. If Contractor fails to fulfill its obligations under this Agreement properly and on time, or otherwise violates any provision of the Agreement, MCEC may terminate the Agreement by written notice to Contractor. The notice must specify the acts or omissions relied on as cause for termination. All finished or unfinished supplies and services provided by Contractor shall, at MCEC's option, become MCEC's property.

9. Set-Off, Etc. MCEC may deduct from and set off against any amounts due and payable to Contractor any back-charges, penalties, or damages sustained by MCEC, by virtue of any breach of this Agreement by Contractor. Nothing herein shall be construed to relieve Contractor of any liability for additional costs resulting from a failure to satisfactorily perform the services. Upon receipt and acceptance of the final payment due under this Agreement in accordance with its original terms or with an early termination by MCEC, the Contractor waives any and all rights or claims arising under this Agreement, unless otherwise agreed in writing by MCEC.

10. Contingent Upon Funds. If MCEC does not have funds available for continued performance for any period of this Agreement, this Agreement must be canceled automatically as of the beginning of the period for which funds were not available. Cancellation does not affect either MCEC's rights or Contractor's rights under any termination clause in this Agreement. The effect of cancellation of the Agreement hereunder will be to discharge both Contractor and MCEC from future performance of the Agreement, but not from their rights and obligations existing at the time of termination. MCEC shall reimburse Contractor for the reasonable value of any nonrecurring costs incurred but not amortized in the price of the Agreement. MCEC shall notify Contractor as soon as it has knowledge that funds may not be available for the continuation of this Agreement.

11. Dissemination of Information. Contractor shall not release any information related to the services or performance of the services under this Agreement, nor publish any final reports or documents, without the prior written approval of MCEC, or unless such release is otherwise required by law or reasonably necessary to be disclosed in judicial proceedings. Contractor shall treat all information obtained by, or on behalf of, MCEC in connection with services performed under this Agreement as confidential and shall not disclose such information except as required by law.

12. Ownership of Documents, Equipment, and Materials. (a) Ownership. Contractor agrees and shall ensure that all documents, equipment, and materials including but not limited to reports, drawings, studies, specifications, estimates, maps, software, photographs, designs, graphics, mechanicals,

artwork, and computations prepared by or for, or purchased by or for, Contractor in connection with the performance of this Agreement shall at any time during the term of this Agreement be available to MCEC and shall become and remain the exclusive property of MCEC upon termination or completion of the services. MCEC shall have the right to use same without restriction and without compensation to Contractor or others other than that provided in this Agreement. MCEC shall be the owner for purposes of copyright, patent or trademark registration, and Contractor hereby transfers to MCEC any rights it may have in the work produced pursuant to this Agreement. Contractor agrees that at all times during the term of this Agreement and thereafter, the works created and services performed shall be “works made for hire” as that term is interpreted under copyright law. To the extent that any products created under this Agreement are not MCEC works for hire, Contractor hereby transfers and assigns to MCEC all of its rights, title and interest (including all intellectual property rights) to all such products created under this Agreement, and will cooperate reasonably with MCEC in effectuating and registering any necessary assignments. (b) Third party; Indemnification. If Contractor obtains or uses for purposes of this Agreement any design, device, material, process, or work covered by patent, copyright, or trademark, Contractor shall ensure MCEC that it is licensed to possess and to use such design, device, material, process, or work. Contractor shall indemnify MCEC, its officials, agents and employees with respect to any claim, action, cost or judgment for patent, trademark or copyright infringement by Contractor arising out of the possession or use of any design, device, material, process, supplies, equipment, services or other work covered by this Agreement.

13. Retention of Records. Contractor shall retain and maintain all records and documents relating to this Agreement for three years after final payment by MCEC hereunder or any applicable statute of limitations, whichever is longer. Contractor shall make such records and documents available for inspection and audit by authorized representatives of MCEC, including the Contract Officer or designees, at all reasonable times.

14. Responsibility for Claims and Liability. MCEC is not liable in any action of tort, contract, or otherwise for any actions of Contractor arising out of this Agreement. Contractor shall be responsible for all damage to life and property due to its activities or those of its agents or employees. Contractor shall indemnify and absolve MCEC, the State, their officials, agents, and employees from and against all claims, suits, judgments, expenses, actions, damages and costs of every name and description, including reasonable attorney's fees, arising out of or resulting from the goods provided or Contractor's performance of services under this Agreement.

15. Compliance with Laws. Contractor hereby represents and warrants that:

(a) It is qualified to do business in the State of Maryland and that it will take such action as, from time to time, may be necessary to remain so qualified;

(b) It is not in arrears with respect to the payment of any monies due and owing the State of Maryland, or any department or unit thereof, including, but not limited to, the payment of taxes and employee benefits, and that it shall not become so in arrears during the term of this Agreement;

(c) It shall comply with all federal, State, and local laws applicable to its activities and obligations under this Agreement; and

(d) It shall obtain, at its expense, all licenses, permits, insurance, and governmental approvals, if any, necessary to the performance of its obligations under this Agreement.

16. Non-Discrimination in Employment. Contractor shall operate under this Agreement so that no person, otherwise qualified, is denied employment or other benefits on the basis of: (a) race,

color, creed, national origin, or marital status; (b) sex or age, except when sex or age constitutes a bona fide occupational qualification; or (c) the physical or mental disability of a qualified individual with a disability. Except in subcontracts for standard commercial supplies or raw materials, Contractor shall include a clause similar to this clause in all subcontracts. Contractor shall provide actual notice of the foregoing to employees and applicants for employment.

17. Subcontracting; Assignment. Contractor may not, during the term of this Agreement or any renewals or extensions of the Agreement, assign any of its rights hereunder nor delegate or subcontract all or any part of its duties hereunder without the prior written approval of the Contract Officer. Any approved subcontract or assignment is subject to all terms and conditions that MCEC deems necessary. MCEC is not responsible for Contractor's obligations to its subcontractors.

18. Insurance: Contractor shall maintain at all times during the performance of this Agreement, a commercial general liability insurance policy with a minimum occurrence coverage in the amount of \$1,000,000; an automobile liability insurance policy in the minimum amount of \$500,000, and workers' compensations insurance for employees in the State. All insurance policies shall:

(a) Provide that the insurance carrier shall not cancel, terminate or otherwise modify the terms and conditions of said policies except upon thirty (30) days written notice to MCEC;

(b) Be evidenced by the original Certificate of Insurance, specifying the required coverage and the insurance carrier's standard additional insured form endorsement, which shall be updated as necessary; and

(c) Be approved as to form and sufficiency by the MCEC.

If the commercial general liability insurance referred to above is written on a Claims Made Form then, following termination of this Agreement, coverage shall survive for a period of not less than five years. Coverage shall also provide for a retroactive date of placement coinciding with the effective date of this Agreement.

19. Agreement Modification. Except as provided in section 1(b) above, this Agreement may be amended only as MCEC and Contractor mutually agree in writing. Except for the specific provision of the Agreement which is amended, the Agreement remains in full force and effect after such amendment and is subject to the same laws, obligations, conditions, provisions, rules, and regulations, as it was before the amendment.

20. Maryland Law. This Agreement shall be construed, interpreted, and enforced according to the laws of the State of Maryland.

21. Entire Agreement. This Agreement, together with any Exhibits incorporated by reference, represents the complete and final understanding of the parties. No other understanding or representations, oral or written, regarding the subject matter of this Agreement, may be deemed to exist or to bind the parties at the time of execution.

The contract between the parties will be embodied in the contract documents which will consist of the following, listed in their order of precedence:

1. The contract and contract modifications executed by both parties;
2. This RFP; and

3. Vendor's proposal.

Modifications of the order of precedence provision of this solicitation will not be accepted. If any terms and conditions inconsistent with requirements of the solicitation are proposed, those terms and conditions must be stated in the proposal.

### **MCEC Cooperative Rider Clause**

1. MCEC provides procurement and technical support services to its Clients through Memorandum of Understanding, Memorandum of Agreement, and other structuring agreements.
2. MCEC, as an agent to member agencies, extends the right to utilize all of the terms, conditions, specifications, and unit or other prices of any contract resulting from this RFP to other public and non-profit agencies participating in current Memorandum of Understanding and/or Memorandum of Agreement with MCEC. This is conditioned upon mutual agreement based on the Rider Clause Approval Form (Appendix 4).
3. MCEC, serving as Lead Entity for this procurement, has included this Cooperative Rider Clause allowing other entities with active Memorandum Of Understanding agreements with MCEC to participate in this procurement pursuant to the Terms specified below.
4. There shall be no obligation on the party of any participating jurisdiction to use the resultant contract(s).

#### **Terms**

5. Upon mutual agreement between the parties, any jurisdiction or entity using the resultant contract(s) may enter into its own contract with the successful Contractor(s).
6. There shall be no obligation on the party of any participating jurisdiction to use the resultant contract(s).
7. Contracts entered into with a participating jurisdiction may contain general terms and conditions unique to that jurisdiction. Including, by way of illustration and not limitation, clauses covering minority participation, nondiscrimination, indemnification, naming the jurisdiction as an additional insured under any required Comprehensive General Liability policies, and venue.

#### **Other Conditions - Contract and Reporting**
